The present lessees are Signal Oil and Gas Company, 76-2/3%, and Humble Oil and Refining Company, 23-1/3%. An application has been received to assign a portion of the Unitized Formation interest of Signal Oil and Gas Company in State Oil and Gas Lease PRC 91.1 to J. A. Humphrey, an individual, and to The Howard Corporation, in the amounts of 11/24 of 1% and 11/12 of 1%, respectively.
