RATIFICATION OF THE SIXTEENTH MODIFICATION OF THE  
1971-1972 PLAN OF DEVELOPMENT AND OPERATIONS AND BUDGET,  
LONG BEACH UNIT, WILMINGTON OIL FIELD, LOS ANGELES COUNTY

The City of Long Beach has requested approval of the Sixteenth Modification of the 1971-1972 Plan of Development and Operations and Budget for the Long Beach Unit.

This Sixteenth Modification will transfer \$270,000 between Budget Divisions to provide sufficient additional funds in PART III.B.2.c(12) Electrical Expense for expenditures that were unanticipated when the 1971-1972 Budget was prepared. These necessary additional funds will be obtained by transfer from five items where surplus funds exist. The total 1971-1972 Budget will remain unchanged.
