13. SETTLEMENT OF TRESPASS DREDGING, TIDE AND SUBMERGED LANDS, SUNSET BAY, VICINITY OF SAM'S SEAFOOD RESTAURANT, HUNTINGTON BEACH, ORANGE COUNTY; MESSRS. ED C. SULKA AND BILL SIVERSON - W 9484.

SETTLEMENT OF TRESPASS DREDGING

PARTY: Messrs. Ed C. Sulka and Bill Siverson.

DREDGE LOCATION: State tide and submerged lands, Sunset Bay, vicinity of Sam's Seafood Restaurant, Huntington Beach.

SPOILS LOCATION: Uplands adjacent to Sam's Seafood Restaurant.

VOLUME DREDGED: 9,694 cubic yards, as estimated by the Division.

SETTLEMENT REQUIREMENTS: Payment to State of \$969.40 (\$0.10 per cubic yard).

OTHER PERTINENT DATA: 1. Party claims to have been unaware of State permit requirements at time of dredging.  
2. Party plans to negotiate further with the State for permission to construct boat docks in dredged area.
