8. AMENDMENT OF RESOLUTION AUTHORIZING ISSUANCE OF LEASE PRC 4196.1, TIDE AND SUBMERGED LANDS LOCATED ADJACENT TO ORMOND BEACH, VENTURA COUNTY; SOUTHERN CALIFORNIA EDISON COMPANY - W 7154, PRC 4196.1.

After consideration of Calendar Item 6 attached, and upon motion duly made and carried, the following resolution was adopted:

THE COMMISSION AMENDS ITS RESOLUTION OF APRIL 28, 1969, MINUTE 11, PAGE 394, TO AUTHORIZE A FIRM ANNUAL RENTAL OF \$1,566 AND OTHER TERMS AND CONDITIONS OF A LONG-TERM LEASE, IN THE FORM OF EXHIBIT "A" ON FILE IN THE STATE LANDS COMMISSION AND BY REFERENCE MADE A PART HEREOF, TO SOUTHERN CALIFORNIA EDISON COMPANY FOR OPERATION AND MAINTENANCE OF EXISTING COOLING WATER CONDUITS ON TIDE AND SUBMERGED LANDS ADJACENT TO ORMOND BEACH, VENTURA COUNTY.

AMENDMENT OF RESOLUTION AUTHORIZING ISSUANCE OF LEASE PRC 4196.1

APPLICANT: Southern California Edison Company.

LOCATION: Two parcels (5.74 and 8.6 acres) of tide and submerged lands located adjacent to Ormond Beach, Ventura County.

LAND USE: Two 14 x 2499-foot concrete structures to provide sea water for cooling purposes. The 8.6-acre parcel was used only during construction.

TERMS OF LEASE: Initial period: 20 years, from April 24, 1969.
Renewal options: 2 additional periods of 14 years each.
Surety bond: \$5,000.

CONSIDERATION: \$1,566 per annum with State reserving the right to review and reset a reasonable rental on each fifth anniversary.

BASIS FOR CONSIDERATION:
6% of appraised value of land.

PREREQUISITE TERMS:
U.S. Army Corps of Engineers permit issued.
Applicant is owner of upland.

STATUTORY AND OTHER REFERENCES:
a. Public Resources Code: Division 6, Parts 1 and 2.
b. Administrative Code: Title 2, Division 3, Articles 1 and 2.

OTHER PERTINENT INFORMATION:
1. On April 28, 1969 (Minute Item #11, page 394), the Commission authorized issuance to Southern California Edison Company of Lease PRC 4196.1, a 9-month right-of-entry permit, for construction of the facility on condition that, when established, the rental of a long-term lease be retroactive to April 24, 1969, the original lease date. Lessee has now executed an agreement which establishes the firm rental for a long-term lease, Exhibit "A".
2. An environmental impact report is not required for this amendment to a prior lease authorization by the Commission. The structures are in place and there is no change in the leased area. This action only sets the firm lease term and rental.
