# INDUSTRIAL LEASE

APPLICANT:

Pacific Gas and Electric Company.

LOCATION:

Three parcels totaling 0.80 acres in the bed of the Pacific Ocean off Point Arena, Mendocino County.

LAND USE:

The installation and maintenance of wave, temperature and current sensing devices.

TERMS OF PROPOSED LEASE:

Initial period: 5 years from December 1, 1972.

CONSIDERATION: \$300 per annum.

BASIS FOR CONSIDERATION:

The minimum as established for an industrial lease.

PREREQUISITE TERMS:

U.S. Army Corps of Engineers permit has been applied for; no lease will be issued without one. Applicant is lessee of upland. Lessee has agreed to abide by any regulations of the Coastal Zone Conservation Commission in this matter.

### EXHIBIT "A"

W 20442

Three parcels of tide and submerged land lying on the floor of the Pacific Ocean and located in Mendocino County, offshore from Point Arena, California.

## PARCEL 1:

A 10 foot wide strip of tide and submerged land lying five feet on each side of the following described centerline:

COMMENCING at a one-inch steel reinforcing rod marking the north-east corner of Section 14, T. 12 N., R. 17 W., M.D.M., as shown in Record of Survey filed for record in Map Case 2, Drawer 16 at page 72, said County Records;

thence S. 82° 08' 33" W., 4,093.54 feet to the TRUE POINT OF BE-GINNING; thence N. 29° 51' 18" E., 1,955 feet; thence N. 80° 47' 20" E., 1,500 feet more or less to the ordinary high water mark and the end of the herein-described centerline.

## PARCEL 2:

A parcel of submerged land 10 feet by 10 feet square, the north line of which runs east and west and the center of said square bears N. 71° 26' 28" W., 9,643.05 feet from the above-mentioned steel reinforcing rod marking the northeast corner of Section 14.

### PARCEL 3:

A parcel of submerged land 10 feet by 10 feet square, the north line of which runs east and west and the center of said square bears N. 66° 19' 37" W., 8,591.71 feet from the above-mentioned one-inch steel reinforcing rod marking the northeast corner of aforesaid Section 14.
