THE COMMISSION AUTHORIZES THE ISSUANCE TO JAMES W. AND LOUISE BEALL OF A TEN-YEAR RENEWAL OF LEASE PRC 3915.1, FROM OCTOBER 1, 1970, UPON THE SAME TERMS AND CONDITIONS, PLUS A PROVISION FOR THE REVIEW AND RESETTING OF A REASONABLE DIFFERENT RENTAL ON THE FIFTH ANNIVERSARY OF THE LEASE, WHICH COVERS THE OPERA-TION OF A COMMERCIAL BOATING FACILITY IN SACRAMENTO RIVER AT FREEPORT, SACRAMENTO COUNTY.

RENEWAL OF COMMERCIAL LEASE PRC 3915.1

APPLICANT: James W. and Louise Beall.

LOCATION: A 0.30-acre parcel of tide and submerged land in Sacramento River near Freeport, Sacramento County.

LAND USE: Operation of a commercial boating facility.

TERMS OF ORIGINAL LEASE:

Initial period: 5 years, from October 1, 1965. Renewal options: 3 additional periods of 10 years each. Surety bond: \$2,000. Public liability insurance: \$100,000/ \$300,000 for personal injury and \$5,000 for property damage.

CONSIDERATION DURING RENEWAL PERIOD OCTOBER 1, 1970 TO SEPTEMBER 30, 1980: \$150, the nominal rental for this lease, is being continued until rentals are reset in this area in 1974-75, pursuant to Section 2005(b)(9) of the California Administrative Code. (This is Commission policy for the San Joaquin-Sacramento Delta area.)

PREREQUISITE ITEMS:

U.S. Army Corps of Engineers permit issued.

Applicant is owner of the upland.
