16. AWARD OF MINERAL EXTRACTION LEASE, OWENS LAKE, INYO COUNTY; MORRISON AND WEATHERLY CHEMICAL PRODUCTS - W 7205, PRC 4754.1.

After consideration of Calendar Item 14 attached, and upon motion duly made and carried, the following resolution was adopted:

THE COMMISSION AUTHORIZES THE ISSUANCE OF A MINERAL EXTRACTION LEASE TO MORRISON AND WEATHERLY CHEMICAL PRODUCTS, THE HIGHEST QUALIFIED BIDDER, IN ACCORDANCE WITH THE PROVISIONS OF DIVISION 6 OF THE PUBLIC RESOURCES CODE, ON 4,480 ACRES OF SOVEREIGN LANDS IN OWENS LAKE. INYO COUNTY, MORE PARTICU-LARLY DESCRIBED IN EXHIBIT "A" ATTACHED AND BY REFERENCE MADE A PART HEREOF, AT A ROYALTY DETERMINED IN ACCORDANCE WITH THE FORMULA R = 0.10 (C - 0.04M) 1.0 PER TON FOR ALL MINERALS EXTRACTED AND/OR PRODUCED AND/OR SOLD FROM THE PROPOSED LEASE AREA ON OWENS LAKE. THE MINIMUM ROYALTY SHALL BE NINETY CENTS (\$0.90) PER TON, AND THE ANNUAL RENTAL SHALL BE \$2.50 PER ACRE.
