AMENDMENT TO LEASE PRC 4769.1

- APPLICANT: Urich Oil Company.
- LOCATION: Adding a 0.161-acre parcel of tide and submerged land in the bed of Pacheco Creek at Avon, Contra Costa County.
- LAND USE: Construction, operation and maintenance of a 12" diameter pipeline for the transport of gasoline and gasoline compononts.

TERMS OF ORIGINAL AUTHORIZATION: Initial period:

Initial period: 25 years, from June 1, 1973.

Renewal options: 2 additional periods of 10 years each.

Surety bond: \$50,000.

Public liability insurance: \$1,000,000 combined single limit.

CONSIDERATION: \$6,571.12 per annum with the State reserving the right to fix a different rental on each fifth anniversary of the lease.

Royalty: \$0.10/cu. yd.

SPECIAL: Effective when all necessary permits obtained; discharge of wastes to bay prohibited.

TERMS OF PROPOSED AMENDMENT:

1. Add Parcel 3 to the legal description of said Lease 30 4769.1; and

2. Change the annual rental from \$6,551.12 per annum to \$6,571.12 per annum.

All other terms and conditions to remain the same.

BASIS FOR CHANGE IN CONSIDERATION: Application of diameter-inch rate to proposed pipeline.

PARCEL 3:

A strip of tide and submerged land lying in the bed of Pacheco Creek (also known as Walnut Creek), approximately 2 miles northeast of the City of Martinez, Contra Costa County, State of California, being more particularly described as follows:

COMMENCING at the State Lands Commission Monument "AVON" having coordinates of X = 1,545,386.26, Y = 561,570.34; thence N 18° 39' 30" W, 231.00 feet; thence S 71° 20' 30" W, 239.53 feet to the ordinary high water mark of the east bank of Pacheco Slough and being the TRUE POINT OF BEGINNING; said ordinary high water mark being described in Boundary Line Agreement No. 7 between Tidewater Associated Oil Company and the State Lands Commission as recorded on March 15, 1951, in Volume 1732, page 35, Official Records of Contra Costa County; thence along said Boundary Line N 59° 02' 55" W, 65.65 feet; thence leaving said Boundary Line S 71° 20° 30" W, 141.64 feet to the ordinary high water mark of the west bank of Pacheco Slough; said ordinary high water mark described in Boundary Line Agreement Nc. 8 between the United Towing Company and the State Lands Commission as recorded on March 15, 1951, in Volume 1732, page 37, Official Records of Contra Costa County; thence along said Boundary Line S 64° 08' 41" E, 71.32 feet; thence leaving said Boundary Line N 71° 20' 30" E, 133.33 feet to the true point of beginning.

This description is based on the California Coordinate System, Zone 3.
