After consideration of Calendar Item 16 attached, and upon motion duly made and carried, the following resolution was adopted:

THE COMMISSION:

- 1. FINDS THAT, IN ACCORDANCE WITH ENVIRONMENTAL IMPACT REPORT NO. 124 ON FILE IN THE OFFICE OF THE STATE LANDS COMMISSION AND BY REFERENCE MADE A PART HEREOF, A DREDGING PERMIT AS RECOMMENDED HEREIN WILL NOT HAVE A SIGNIFICANT DETRIMENTAL ENVIRONMENTAL EFFECT.
- 2. AUTHORIZES THE ISSUANCE OF A DREDGING PERMIT TO STANDARD OIL COMPANY OF CALIFORNIA, SUBJECT TO ISSUANCE OF A U.S. CORPS OF ENGINEERS PERMIT, FOR THE REMOVAL OF 622,000 CUBIC YARDS OF MATERIAL FROM THE SUBMERGED LAND OF SAN FRANCISCO BAY DESCRIBED IN EXHIBIT "A" ATTACHED AND BY REFERENCE MADE A PART HEREOF; IN CONSIDERATION OF THE PUBLIC BENEFIT AND IMPROVE-MENT OF NAVIGATION; PROVIDED THAT ALL MATERIAL SO REMOVED SHALL BE DIS-POSED OF AT THE ARMY CORPS OF ENGINEERS PUBLIC DUMPING GROUNDS NO. 3 LOCATED SOUTH OF ALCATRAZ ISLAND; SUCH PERMIT TO BE EFFECTIVE DURING THE PERIOD OCTOBER 1, 1973, TO SEPTEMBER 30, 1974.

DREDGING PERMIT

APPLICANT: Standard Oil Company of California.

DREDGE LOCATION: Two parcels totaling 49 acres adjacent to Standard's Richmond Refinery Long Wharf.

DREDGE VOLUME: 622,000 cubic yards including 250,000 cubic yards to be dredged pursuant to existing Lease PRC 236.1.

SPOILS LOCATION: Public dump area south of Alcatraz Island.

CONSIDERATION: Improvement of navigation.

OTHER PERTINENT INFORMATION:

- 1. Applications for permits for the project have been made to the San Francisco Bay Conservation and Development Commission and the U.S. Army Corps of Engineers. The dredging permit will not be effective until such time as these permits are issued.
- 2. An environmental impact report has been circulated to affected governmental agencies. No adverse comments were received.
- 3. The dredge area includes 32 acres located within the grea of Lease PRC 236.1 which lease authorized dredging.

IT IS RECOMMENDED THAT THE COMMISSION:

1. FIND THAT, IN ACCORDANCE WITH ENVIRONMENTAL IMPACT REPORT NO. 124 ON FILE IN THE OFFICE OF THE STATE LANDS COMMISSION AND BY REFERENCE MADE A PART HEREOF, A DREDGING PERMIT AS RECOMMENDED HEREIN WILL NOT HAVE A SIGNIFI-CANT DETRIMENTAL ENVIRONMENTAL EFFECT.

2. AUTHORIZE THE ISSUANCE OF A DREDGING PERMIT TO STANDARD OIL COMPANY OF CALIFORNIA, SUBJECT TO ISSUANCE OF A U.S. CORPS OF ENGINEERS PERMIT, FOR THE REMOVAL OF 622,000 CUBIC YARDS OF MATERIAL FROM THE SUBMERGED LAND OF SAN FRANCISCO BAY DESCRIBED IN EXHIBIT "A" ATTACHED AND BY REFER-ENCE MADE A PART HEREOF; IN CONSIDERATION OF THE PUBLIC BENEFIT AND
