TERMINATION OF LEASE PRC 2569.1

APPLICANT: Robert W. McCune and Wayne Winther.

LOCATION: A 0.433-acre parcel of tide and submerged land in the San Joaquin River near the Antioch Bridge, Contra Costa County.

LAND USE: A proposed dock and restaurant (never built).

TERMS OF ORIGINAL LEASE:

Initial period: 15 years, from April 28, 1960.

Renewal options: 2 additional periods of 10 years each.

Surety bond: \$3,000.

Public liability insurance: \$50,000/\$100,000 for personal injury.

CONSIDERATION: \$150 per annum.

STATUTORY AND OTHER REFERENCES:

a. Public Resources Code: Div. 6, Parts 1 and 2.
b. Administrative Code: Title 2, Div. 3, Arts. 1 and 2, as amended effective May 10, 1969.

OTHER PERTINENT INFORMATION:

- 1. The site has never been developed as proposed by the lessees.
- 2. The lessees are in default in regard to rent, bond and insurance provisions of the lease, and performance of the condition that a restaurant be constructed.
- 3. Attempts have been made by regular and certified mail to elicit rent, a bond and insurance, or a quitclaim deed from the lessees, to no avail.
- 4. In the opinion of the Division, it is in the best interest of the State to terminate this lease by filing a Notice of Termination to be effective as of the date the delinquency began: April 27, 1969.
