INCORPORATION OF TIDE AND SUBMERGED LANDS TO THE CITY OF SAN DIEGUITO

At its July 1973 meeting, the State Lands Commission approved the legal description of the proposed incorporation of the City of Solana Beach as required by Government Code Section 34302.3. Subsequent to the approval, the Local Agency Formation Commission of San Diego County rejected the proposed incorporation by the City of Solana Beach and instead, approved the proposed incorporation of the City of San Dieguito. The proposed incorporation of the City of San Dieguito includes all the tide and submerged lands that were included in the description of the proposed incorporation of Solana Beach. However, the incorporation of San Dieguito includes other tide and submerged lands as well. The Local Agency Formation Commission of San Diego County has requested that the State Lands Commission approve the legal description of the proposed incorporation of tide and submerged lands to the City of San Dieguito. These tide and submerged lands include the Pacific Ocean, San Elijo Lagoon, and Batiquitos Lagoon. Pursuant to California Government Code Section 34302.3 the State Lands Commission is required by law to approve or disapprove a description of the boundaries of the incorporation in respect to the included Stateowned tide and submerged lands.

The description of the boundaries has been reviewed by the Division and has been found to be technically sufficient and in compliance with Section 34302.3 of the Government Code.
