

8. APPROVAL OF PROPOSED DRILLING OF NEW WELL "STATE 392" J-185, EXCHANGE OIL AND GAS LEASE E 392.1, AND REDRILLING WELLS "STATE 426" 45, "STATE 426" 2-A, AND "STATE 426" 24-A, STATE OIL AND GAS LEASE PRC 426.1; HUNTINGTON BEACH OFFSHORE, ORANGE COUNTY; BURMAH OIL AND GAS COMPANY - E 392.1, PRC 426.1.

After consideration of Calendar Item 6 attached, and upon motion duly made and carried, the following resolution was adopted:

THE COMMISSION:

1. DETERMINES THAT AN ENVIRONMENTAL IMPACT REPORT HAS NOT BEEN PREPARED FOR THIS ACTIVITY BECAUSE IT IS AN ONGOING PROJECT UNDER PRC 21169 AND 14 CAL. ADM. CODE 15070.
2. AUTHORIZES THE APPROVAL OF DRILLING WELL "STATE 392" J-185, AND REDRILLING WELLS "STATE 426" 45, "STATE 426" 2-A, AND "STATE 426" 24-A, IN ACCORDANCE WITH THE TERMS AND CONDITIONS OF EXCHANGE OIL AND GAS LEASE E 392.1 AND STATE OIL AND GAS LEASE PRC 426.1, BURMAH OIL AND GAS COMPANY, LESSEE, AND THE RULES AND REGULATIONS OF THE COMMISSION.

APPROVAL OF PROPOSED DRILLING OF NEW WELL "STATE 392" J-185,  
EXCHANGE OIL AND GAS LEASE E 392.1, AND REDRILLING OF WELLS  
"STATE 426" 45 AND "STATE 426" 2-A AND "STATE 426" 24-A,  
STATE OIL AND GAS LEASE PRC 426.1,  
HUNTINGTON BEACH OFFSHORE, ORANGE COUNTY

LEASES: E 392.1 and PRC 426.1.  
LESSEE: Burmah Oil and Gas Company.  
COUNTY: Orange.  
AREA: Huntington Beach Offshore.

PERTINENT INFORMATION:

Burmah has initiated a full-scale waterflood operation. Production performance clearly indicates that the program has been successful, resulting in an economic advantage to the State.

In order to maintain a coordinated and uninterrupted secondary recovery development program, Burmah has submitted an application to drill "State 392" J-185, and redrill "State 426" 45, "State 426" 2-A, and "State 426" 24-A, as water injection wells.

The proposed wells are part of the plan for secondary recovery operations approved by the Commission on November 6, 1963 (Minute Item 21, page 9362), and on October 23, 1973 (Minute Item 15, page 856). An environmental impact report is not required as this is an ongoing project. The proposed injection intervals in these wells will provide the best development spacing for optimum secondary response. The surface locations of these wells are on the uplands.

The proposed drilling, redrilling, and completion programs have been reviewed by the Division and determined to be in accordance with good engineering practices and the rules and regulations of the Commission. The Division of Oil and Gas has approved the drilling and redrilling of these wells. The proposed wells are part of the plan of development exempted from permit requirements by the South Coast Regional Commission.
