AREA, TYPE LAND AND LOCATION: A 0.069-acre strip of submerged land across the American River approximately 650 feet downstream from the Sunrise Boulevard Bridge, Sacramento County.

LAND USE: Continued maintenance of a bridge.

TERMS OF ASSIGNED LEASE: Initial period: 2 years, from July 20, 1965.

Renewed for one additional period of eight years, to July 19, 1975.

CONSIDERATION: \$150 per annum.

STATUTORY AND OTHER REFERENCES:
