OTHER PERTINENT INFORMATION:

1. WP 3083, WP 3167, WP 3185, WP 3244, WP 3247, WP 3253, and WP 3659 cover existing facilities which have been in place for a number of years under previously authorized permits which recently expired. All are in a good state of repair, and are therefore exempt pursuant to PRC 21065, 14 Cal. Adm. Code 15037, and 2 Cal. Adm. Code 2910.
2. W 20616, W 20744, and W 20771 cover proposed floating structures which will occupy under 3000 square feet and are therefore exempt from the provisions of CEQA pursuant to PRC 21085; 14 Cal. Adm. Code 15100, et seq.; and 2 Cal. Adm. Code 2910.
3. Permits covering structures in Lake Tahoe will include a condition subsequent that if any structure authorized is found to be in nonconformance with the Tahoe Regional Planning Agency's Shorezone Ordinance and if any alteration, repair, or removal required pursuant to said Ordinances is not accomplished within the designated time period, then the permit will be automatically terminated, effective upon notice by the State, and the site shall be cleared pursuant to the terms thereof.
