REVIEW OF FOURTH QUARTER 1973-1974 FISCAL YEAR  
 PRODUCTION AND REVENUE AND ESTIMATE OF 1974-1975 FISCAL YEAR  
 AND REVENUE, PARCEL "A", CITY OF LONG BEACH,  
 WILMINGTON OIL FIELD, LOS ANGELES COUNTY

The Commission, at its meeting of January 26, 1972, directed the Division to prepare and submit annual fiscal year estimates of oil and gas production, oil and gas liquids value, investment and expense expenditures, net revenue and net profits from Parcel "A", and to review quarterly such annual estimates. In compliance with this directive, estimates for the 1973-1974 fiscal year were prepared by the Division and presented to the Commission at its meeting of August 30, 1973.

The Division has reviewed these 1973-1974 fiscal year estimates in the light of actual production and expense through the end of the fiscal year. The Chapter 138 oil revenue for sharing from Parcel "A" during the State 1973-1974 fiscal year was \$3,323,000, \$824,000 above the original estimate of \$2,499,000. This revenue increase was due principally to the higher price received for crude oil combined with a slight reduction in estimated expenditures.

Improvement in production efficiency in conjunction with producing well redrills has flattened the oil rate decline in comparison to the previous year.

For the 1974-1975 fiscal year, the Division has prepared the following revenue estimates:
