PROPOSED EXPENDITURE OF TIDELAND OIL REVENUE CITY OF LONG BEACH

CAPITAL IMPROVEMENT PROJECT:

Construct pumpout units in the Long Beach Marina. Each pump station consists of one or more pumpout units with new sewer, electrical and fresh water lines constructed to join existing landside mains.

PURPOSE OF THE PROJECT:

The pumpout units will be used to provide disposal facilities for sewage holding tanks installed on small boats using the marina.

COST OF THE PROJECT:

\$98,400.
