7. 16-YEAR NONCOMMERCIAL LEASE, TIDE AND SUBMERGED LAND IN DISCOVERY CHANNEL, HUNTINGTON HARBOUR, ORANGE COUNTY; HUNTINGTON HARBOUR CORPORATION - W 20759, PRC 4953.1.

During consideration of Calendar Item 5 attached, Commissioner Verne Orr requested the staff to come back at the next Commission meeting with a suggested revision to the basic rental rate which would be more reasonable than the existing six percent of appraised market value.

Upon motion duly made and carried, the following resolution was adopted:
