The State Lands Commission is a party to a United States condemnation action brought by the United States Attorney entitled <u>United States v. 429.09</u> <u>Acres of Land, More or Less, etc., et al.</u>, filed in the United States <u>District Court, Eastern District of California, Civil No. F-729</u>, involving land in Kings County.

Upon examination of the Commission's records pertinent to the area, it was ascertained that there is no interest held by the State Lands Commission as to Parcel No. 21 listed in this condemnation action. The subject parcel is located within the NEMA of Section 26, T 19 S, R 19 E, MDM.

The United States filed a motion for summary judgment as to Parcel No. 21 and such motion was heard December 9, 1974. In order to prevent a Default Judgment being taken against the State Lands Commission, the Office of the Attorney General f.led a Disclaimer in this case.
