## AUTHORIZATION TO FILE DISCLAIMER OF INTEREST IN UNITED STATES V. 1,393.464 ACRES OF LAND, MORE OR LESS, ETC., ET AL., UNITED STATES DISTRICT COURT, EASTERN DISTRICT OF CALIFORNIA, CIVIL NO. C-69 369 RFP

The State Lands Commission is a party to a United States condemnation action brought by the United States Attorney entitled <u>United States v. 1,393.464</u> <u>Acres of Land, More or Less, etc., et al.</u>, filed in the United States District Court, Eastern District of California, Civil No. C-69 369 RFP, involving Land in Contra Costa County.

Upon examination of the Commission's records pertinent to the area, it was ascertained that there is no land involved in Parcel 572 which is subject to the jurisdiction of the State Lands Commission. Parcel 572 is sold swamp and overflowed lands located within the E½ of Section 5, T 2 N, R 1 W, MDM, near Port Chicago, Contra Costa County.

Inasmuch as this suit involves lands over which the Commission has no juricdiction, it is recommended that a disclaimer be filed on behalf of the State Lands Commission, disclaiming any compensable right, title, or interest in the parcel involved.
