AUTHORIZATION TO FILE DISCLAIMER IN <u>UNITED STATES V. 429.09 ACRES OF LAND,</u> <u>MORE OR LESS, ETC., ET AL.,</u> <u>UNITED STATES DISTRICT COURT,</u> EASTERN DISTRICT OF CALIFORNIA, CIVIL NO. F-729

The State Lands Commission is a party to a United States condemnation action brought by the United States Attorney entitled United States v. 429.09 Acres of Land, More or Less, etc., et al., tiled in the United States District Court, Eastern District of California, Civil No. F-729, involving land in Kings County.

Upon examination of the Commission's records pertinent to the area, it was ascertained that there is no interest held by the State Lands Commission as to Parcel Nos. 2, 3, 4, 5, 6, 7, 10, 11, 12, 13, 14, 15, 16, 17, 18, 20, 22 and E-23 listed in this condemnation action. The subject parcels are located within Sections 26, 27, 34, 35, T 19 S, R 19 E, MDM.

Inasmuch as this suit involves certain land over which the Commission has no jurisdiction, it is recommended that a disclaimer be filed on behalf of the State Lands Commission, disclaiming any compensable right, title, or interest in Parcel Nos. 2, 3, 4, 5, 6, 7, 10, 11, 12, 13, 14, 15, 16, 17, 18, 20, 22 and E-23.

The United States filed a Motion for Summary Judgment as to Parcel No. 1 and such motion was heard on March 10, 1975. In order to prevent a default judgment being taken against the State Lands Commission, the Office of the Attorney General filed a disclaimer in the above case. Parcel No. 1 is located in Section 27, T 19 S, R 19 E, MDM.
