Gulf with American Thermal drilled a well in Surprise Valley in 1974 near permits PRC 4957, PRC 4958, and PRC 4959 (Exhibit "A"). No geothermal resources were encountered and the well was abandoned. The Bureau of Land Management recently offered 16 leases in the Surprise Valley area and bids were only received on 5 of the parcels. The bids ranged from \$3.15 to \$21.53 per acre. Gulf feels that additional exploration is unwarranted and has quitclaimed the permits.
