To perform maintenance dredging of approximately 30,000 cubic yards, on tide and submerged land, at the Pier 91 facility in Carquinez Strait as

described on Attached Exhibit "A".

SPOILS PLACEMENT:

All material dredged to be spoiled at the San Francisco EPA disposal Site 9, at Carquinez Strait.

PURPOSE:

To maintain adequate depths for safely loading

and unloading vessels.

CONSIDERATION:

Royalty of \$0.15 per cubic yard for removal of

State-owned minerals.

ENVIRONMENTAL IMPACT CONSIDERATION:

- An Environmental Impact Report is not required. This project is within the purview of 2 Cal. Adm. Gode 2907, Class 4, which exempts a maintenance dredging operation.
- This project is situated on State land identified as possessing significant environmental values, pursuant to Public Resources Gode 6370.1, and is classified in a significant use category, Class C: Multiple Use. Staff review indicates that there will be no significant effect upon the identified environmental values. The staff of the Division has received no adverse comments on this project.

OTHER PERTINENT DATA:

- Silt and bay mud to be removed by clamshell and transported to the disposal site by bottom dump scow.
- Permits were secured from the followin; agencies:
