APPLICANT:

Harold J. and Ardella F. Shanks

AREA, TYPE LAND AND LOCATION:

One 2,400 square foot parcel and one circular parcel 20 feet in diameter consisting of 314 square feet of submerged land in Lake Tahoe near Rubicon Point, El Dorado County.

LAND USE:

One buoy and existing recreational pier.

TERMS OF PROPOSED LEASE:

Initial period: 5 years from January 3, 1976.

CONSIDERATION: \$75 per annum.

BASIS FOR CONSIDERATION:

\$75 fixed rental for this type of lease or permit.

PREREQUISITE TERMS, FEES AND EXPENSES:

Applicant is owner of upland.

Filing fee and first year's rent for buoy has been received.

STATUTORY AND OTHER REFERENCES:

A. Public Resources Code: Div. 6, Parts 1 & 2.

B. Administrative Code: Title 2, Div. 3, Arts. 1, 2, 10 § 11.

OTHER PERTINENT INFORMATION:

- The pier is determined to be cent free pursuant to Public Resources Code 6503.
- The Applicant did not submit the expense fee and the staff believes it is in the best interest of the State to waive the fee.
- 3. Only the budy is subject to monetary rental requirements.

- 4. An Environmental Impact Report is not required. This transaction is within purview of 2 Cal. Adm. Code 2907(a) which exempts an existing structure or facility that is in an acceptable state of repair and there is no evidence of record to show injury to adjacent property, shoreline erosion, or other types of environmental degradation.
- 5. This project is situated on State land identified as possessing significant environmental values, pursuant to Public Resources Code 6370.1, and is classified in a significant use category, Class B: Limited Use.

Staff review indicates that there will be no significant effect upon the identified environmental values. This is an existing facility for which no adverse comments have been received.

A parcel of land in the State owned bed in Lake Tabor, lying immediately beneath and ten feet on all sides of an existing pier, lying easterly of a portion of Lot 6, Block A as shown on the Official Map of Rubicon Properties, filed in the office of the County Recorder of the County of El Dorado, State of California, said portion of Lot 6 is described in that deed from Casper to Shanks, dated March 9, 1973 recorded in Book 1187 at Page 641, Official Records of El Dorado County, more particularly described as follows:

BEGINNING at the S. W. Corner of the existing pier; thence southerly ten feet at a right angle to the southerly edge of the pier, thence easterly 206 feet, parallel with the southerly edge of the pier; thence northerly 32 feet, parallel to the easterly end of the pier; thence westerly 48 feet, parallel to the northerly edge of pier, thence southerly 8 feet, at a right angle to the northerly edge of pier; thence 8 feet, at a right angle to the northerly edge of pier; thence southerly 162 feet, parallel to the northerly edge of pier; thence southerly 14 feet, at a right angle to the Northerly edge of pier to the point of beginning:
