# OTHER PERTINENT INFORMATION:

- WP 3527, WP 3563, WP 3577, WP 4483, and WP 5012 cover existing facilities which have been in place for a number of years under previously authorized permits. W 20183 covers an existing facility which has not been under prior permir. All facilities are in an acceptable state of repair and are therefore exempt from the requirements of CEQA, pursuant to PRC 21085; 14 Cal. Adm. Code 15100, and 2 Cal. Adm. Code 2907.
- The facilities are situated on State land identified as nossessing significant environmental values, pursuant to Public Resources Code 6370.1, and are classified in a significant use category, Place P Limited Hsc. Staff review indicates that there will be no significant effect upon the identified environmental values. These are existing facilities for which no adverse comments have been received.
- WP 3563, WP 5012, and W 20183 with existing facilities in Huntington Harbour, Oranie County; Taylor Slough, Contra Costa County; and Sacramento River, Sacramento County, respectively, did not submit the expense fee, and the staff believes it is in the best interest of the State to waive the fee in view of present controversy.
