19. REVISION IN LEASE RENTAL AFTER ROUTINE REVIEW, TIDE AND SUBMERGED LAND IN THE MOKELUMNE RIVER, SACRAMENTO COUNTY; LLOYD F. KORTH, DBA KORTH'S PIRATES LATE MARINA - WP 2215.

During consideration of Calendar Item 19 attached, Mr. Robert C. Hight, Staff Counsel, stated that the staff had attempted to negotiate the lease revision with Mr. Kerth. Mr. Hight indicated that Mr. Korth advised he would have an appraisal report in the near future on which to base discussions. However, at the present time, the report was not ready.

Mr. Bruce Allen, attorney, representing Mr. Korth, appeared. Mr. Allen advised that Mr. Korth recently hired an appraiser, but due to the appraiser's busy schedule, the report would probably not be ready until the July or August meeting. Mr. Allen therefore requested the matter be deferred for 30 days. He also brought up the point that they had not received notice of the rent increase until two days before it was to become effective. Due to the question of notice, the item was deferred 30 days.
