AUTHORIZATION TO PROCEED WITH THE ADOPTION OF  
COASTAL PLAN REGULATIONS

The California Coastal Zone Conservation Plan which was submitted to the Legislature in December 1975; makes many policy recommendations which fall within the statutory purview of the State Lands Commission.

Unnoticed, the State Lands Commission has consistently expressed its concern for fulfilling its obligations to manage and protect the coastal lands and resources under its jurisdiction. This concern has been expressed in existing, but uncodified, Commission policies, procedures, rules and regulations which are quite similar to those recommended by the California Coastal Plan.

The Commission has statutory authority, pursuant to Section 6301 et seq. of the Public Resources Code, to implement many of the objectives and policies of the California Coastal Plan which apply to lands under the Commission's jurisdiction. This can be accomplished through the formal adoption of written rules and regulations in the California Administrative Code.

Preliminary language to accomplish this objective, presented as Exhibit "A", on file with the State Lands Commission and by reference made a part hereof, is sufficient for the purposes of holding public hearings to revise and formalize these items into rules and regulations that can be incorporated within the California Administrative Code.

EXHIBIT: A. Article 12.

IT IS RECOMMENDED THAT THE COMMISSION AUTHORIZE SUCH STEPS AS MAY BE NECESSARY AND APPROPRIATE, INCLUDING PUBLICATION AND PUBLIC HEARING, AS REQUIRED BY THE ADMINISTRATIVE PROCEDURE ACT FOR CHANGES IN TITLE 2, DIVISION 3, CALIFORNIA ADMINISTRATIVE CODE, TO ADOPT NEW ARTICLE 12 GENERALLY IN THE FORM ON FILE IN THE OFFICE OF THE STATE LANDS COMMISSION AND BY REFERENCE MADE A PART HEREOF.
