By memorandum dated November 20, 1970, the Department of Transportation, Division of Highways, applied to the Commission for a reservation of State sovereign lands for a Lridge crossing the Salinas River, between Castroville and Marina, Monterey County.

Processing of the transaction was held up pending a determination of the State's interest in the Salinas River. During the intervening period, the bridge construction project was completed. The Department of Transportation has now submitted an acceptable plat of the reserved lands.
