SPECIAL USE ROAD PERMIT

On May 25, 1976, the State Lands Division made application to the Forest Service, Takee National Forest, for a Special Use Road Permit. Said application was made for the purpose of obtaining a road access route over federal lands administered by the Forest Service to State school rands described as Section 8, T 15 N, R 14 E, MDM, in Placer County.

The parcel (Section 8) is included in a proposed land exchange, authorized by Chapter 973, Statutes of 1973, whereby the State would acquire a parcel affording 1.6 miles of ocean frontage in Santa Cruz County.

The access road is 1.25 miles in length and contains approximately 5.6 acres. It commences at the Foresthill Divide Road some 31 road miles northeasterly of the town of Foresthill at an approximate elevation of 1980 feet, then runs south for about 1/4 mile, turns northeasterly and continues to the west boundary of said Section 8, vicinity of the west quarter corner at an approximate elevation of 6240 feet. The average grade of the road is 9.6 percent in its total descent of approximately 640 feet.

Acceptance of the Special Use Road Permit will allow the State Lands Commission the optimum flexibility in management of the parcel. Construction of the road or any other use of this parcel beyond its present use, will require additional environmental consideration.

On September 27, 1976, the Forest Supervisor, Tahoe National Forest, forwarded the State Lands Division a Class E Special Use Permit for review and signature. Authorization for execution of the subject road permit is hereby recommended by the Division staff.
