DREDGING PERMIT

APPLÍCANT:

City of Sacramento 35.20 Fifth Avenue Sacramento, Calafornia 95817

PROPOSED DREDGING:

To perform maintenance dredging on tide and submerged granted lands at Miller and Garcia Bend Parks, Sacramento County, as described in Exhibits "A" and "B" attached.

SPOILS PLACEMENT:

The sport to be deposited on City property and, when dry, removed for usage by the City in top-dressing park lawns, Midling holes. where City trees are removed, and related City maintenance.

OWNERSHIP:

Drodge areas are within grants to the City of Sacramento with minerals reserved to the State of California.

PURPOSE:

Dredging will provide adequate depth to launch ramp facilities to accommodate vessels using such facilities and at Miller Park Harbor mouth.

CONSTDERATION: Public benefit, no royalty required.

ENVIRONMENTAL IMPACT CONSIDERATION:

- An Environmental Impact Report is not required. This project is within the purview of 2 Cal. Alm. Code 2907, Class 4, which exempts maintenance dredging operations.
- This project is situated on State land identified as possessing significant environmental values, pursuant to Public Resources Code 6370.1, and is classified in a significant use category, Class B: Limited Use. Staff review indicates that there will be no significant effect upon the identified environmental values. The Staff of the Division has received no adverse comments on this project.

OTHER PERTINENT DATA:

- Proposed dradging at Carcia Bend Park area described in Exhibit "A" will average approximately 300 cubic yards annually removed from the launch ramp.
- Proposed dredging at Miller park area described in Exhibit "B" will average approximately 200 cubic yards annually which is to be removed from the ramp and 1,500 cubic yards every two years to be removed from the Harbor mouth.
- The applicant has requested a permit for a period of 10 years.
- Applicant has requested permission to perform the dredging from the following agencies:
 - U.S. Army Corps of Engineers. á٠
 - Regional Water Quality Control Board. b.
 - Department of Fish and Game.

This permit will he issued contingent upon the applicant securing permission from those agencies.

Effective period of the permit to be January 26, 1977 to December 31, 1979.
