APPLICANT: South East Regional Reclamation Authority

AREA, TYPE LAND AND LOCATION: 5.01 acres of tide and submerged land in the
Gulf of Santa Catalina, Orange County.

LAND USE: Construction and maintenance of an ocean outfall.

TERMS OF PROPOSED LEASE: Initial period: 49 years from January 15, 1977.

CONSIDERATION: The public health and safety with the State
reserving the right at any time to set a
monetary rental if the Commission finds such
action to be in the State's best interest.

PREREQUISITE TERMS, FEES AND EXPENSES: Processing costs have been received.

STATUTORY AND OTHER REFERENCES:
A. Public Resources Code: Div. 6, Parts 1 & 2.

OTHER PERTINENT INFORMATION:
1. The annual rental value of the site is
estimated to be \$400.
2. A final environmental impact statement was
prepared by the U.S. Environmental Protection
Agency pursuant to NEPA and implementing
regulations. A Notice of Determination
filed by the South East Regional Reclamation
Authority has been received.
3. This project is situated on State land
identified as possessing significant environ-
mental values pursuant to Public Resources
Code 6370.1, and is classified in a use
category, Class B, which authorizes
Limited Use.

2. CERTIFY THAT THE INFORMATION CONTAINED IN THE ENVIRONMENTAL IMPACT STATEMENT OF THE U.S. ENVIRONMENTAL PROTECTION AGENCY HAS BEEN REVIEWED AND CONSIDERED BY THE COMMISSION.
3. DETERMINE THAT THE PROJECT WILL HAVE A SIGNIFICANT EFFECT ON THE ENVIRONMENT.
4. DETERMINE THAT OCEAN DISCHARGE IS THE MOST ENVIRONMENTALLY SOUND METHOD OF DISPOSING OF WASTE DISCHARGE.
5. FIND THAT GRANTING OF THE PERMIT OR LEASE WILL HAVE NO SIGNIFICANT EFFECT UPON ENVIRONMENTAL CHARACTERISTICS IDENTIFIED PURSUANT TO SECTION 6370.1, OF THE PUBLIC RESOURCES CODE.
6. AUTHORIZE ISSUANCE TO SOUTH EAST REGIONAL RECLAMATION AUTHORITY OF A 49-YEAR PUBLIC AGENCY PERMIT FROM JANUARY 15, 1977; IN CONSIDERATION OF THE PUBLIC HEALTH AND SAFETY WITH THE STATE RESERVING THE RIGHT AT ANY TIME TO SET A MONETARY RENTAL IF THE COMMISSION FINDS SUCH ACTION TO BE IN THE STATE'S BEST INTEREST; FOR THE CONSTRUCTION AND MAINTENANCE OF AN OCEAN OUTFALL ON THE LAND DESCRIBED ON EXHIBIT "A" ATTACHED AND BY REFERENCE MADE A PART HEREOF.
