(RECREATIONAL USE)

APPLICANT: Bay Cities Refuse Service, Inc.
c/o Lewis Figone
Box 277
El Cerrito, California 94530

AREA, TYPE LAND AND LOCATION:
A 1985 square-foot parcel of submerged land
in Lake Tahoe, Tahoe, Placer County.

LAND USE: Proposed recreational pier.

TERMS OF PROPOSED LEASE:
Initial period: 10 years from April 1, 1977.
Surety bond: \$1,000.00.

CONSIDERATION: \$30 per annum.

BASIS FOR CONSIDERATION:
\$30 fixed rental for this type of permit.
(Calculated from ordinary low water line.)

PREREQUISITE TERMS, FEES AND EXPENSES:
Applicant is owner of upland.
Filing fee, first year's rent, and surety
bond of \$1,000 has been received.

STATUTORY AND OTHER REFERENCES:
A. Public Resources Code: Div. 6, Parts 1 & 2.
B. Administrative Code: Title 2, Div. 5,
Arts. 1, 2, 10 & 11.

OTHER PERTINENT INFORMATION:
1. State's permit specifies that should any
structure be found in non-conformance with
the Tahoe Regional Planning Agency's Shore-
zone Ordinance, including needed repairs,
alterations or removal pursuant to said
ordinance, the State's permit will be auto-
matically terminated and also specifies
that if any structure is found to be upon

or adjacent to land claimed by the County of Placer without their consent and approval, State's permit terminates on notice by State.

2. This project is situated on State land identified as possessing significant environmental values pursuant to Public Resources Code 6370.1, and is classified in a use category, Class B which authorizes Limited Use.
3. Approvals Obtained:
 - a. Tahoe Regional Planning Agency.
 - b. Corps of Engineers.

IT IS RECOMMENDED THAT THE COMMISSION:

1. DETERMINE THAT AN ENVIRONMENTAL IMPACT REPORT HAS NOT BEEN PREPARED FOR THIS ACTIVITY AS SUCH REPORT IS NOT REQUIRED UNDER THE PROVISIONS OF PRC SECTION 21085, 14 CAL. ADM. CODE SECTION 15100 ET SEQ., AND 2 CAL. ADM. CODE SECTION 2907.
2. FIND THAT GRANTING OF THE PERMIT WILL HAVE NO SIGNIFICANT EFFECT UPON ENVIRONMENTAL CHARACTERISTICS IDENTIFIED PURSUANT TO SECTION 6370.1 OF THE PUBLIC RESOURCES CODE.
3. AUTHORIZE ISSUANCE TO BAY CITIES REEFUSE SERVICE, INC. OF A TEN-YEAR GENERAL PERMIT (RECREATIONAL USE) FROM APRIL 1, 1977, IN CONSIDERATION OF ANNUAL RENT IN THE AMOUNT OF \$30.00 WITH STATE RESERVING THE RIGHT TO FIX A DIFFERENT RENTAL ON EACH FIFTH ANNIVERSARY OF THE LEASE; PROVISION OF A \$1,000.00 SURETY BOND; FOR A PROPOSED RECREATIONAL PIER ON THE LAND DESCRIBED ON EXHIBIT "A" ATTACHED AND BY REFERENCE MADE A PART HEREOF.
