reconstruction of an existing county road bridge. Upon completion of bridge construction, cable will be reinstalled in a permanent conduit on the bridge.

- An Environmental Impact Report is not required. This transaction is within the purview of 2 Cal. Adm. Code 2907, Class 1B which exempts an existing structure or facility that is in an acceptable state of repair and there is no evidence of record to show injury to adjacent property, shoreline erosion, or other types of environmental degradation. This section also provides for the minor modification of an existing facility.
 - This project is situated on State land identified as possessing significant environmental values pursuant to Public Resources Code 6370.1, and is classified in a use categony, Crass B which authorizes, limited use.

Staff review indicates that there will be no significant effect upon the adentified environmental values. This is a minor modification of an existing facility for which no adverse comments have been received.
