AREA, TYPE LAND AND LOCATION:

An 0.362 acre parcel of submerged land in the Sacramento River near Glenn, Glenn

LAND USE:

Maintenance of a small boat marina. TERMS OF PROPOSED LEASE:

Initial period: 15 years from September 1, 1973.

Renewal options: 3 successive periods of 10 years each.

Insurance: Combined single limit of \$300,000.

CONSIDERATION: \$225 per annum, with the State reserving the right to fix a different rental on each fifth anniversary of the lease.

BASIS FOR CONSIDERATION:

\$225 minimum rental for this type of lease. PREREQUISITE TERMS, FEES AND EXPENSES:

Applicant is owner of upland.

Filing fee has been received.
