GENERAL PERMIT PUBLIC AGENCY USE

APPLICANT:

Sacramento Regional County Sanitation District 827 Seventh Street Sacramento, California 9581

AREA, TYPE LAND AND LOCATION:

An 0.058 acre parcel of tide and submerged land in the bed of the Sacramento River, City of Sacramento, Sacramento County.

LAND USE:

Modification, reconstruction and continued maintenance of an existing storm water outfall pipeline.

TERMS OF PROPOSED PERMIT:

Initial period: 49 years from December 1, 1977.

CONSIDERATION:

The public health and safety, with the State reserving the right at any time to set a monetary rental if the Commission finds such action to be in the State's best interest.

PREREQUISITE TERMS, FEES AND EXPENSES:

Applicant is permittee of upland.

Processing costs have been received.

STATUTORY AND OTHER REFERENCES:

A. Public Resources Code: Div. 6, Parts 1 & 2.

B. Administrative Code: Title 2, Div. 3, Arts. 1, 2, 10 & 11.

OTHER PERTINENT INFORMATION:

1. The proposed project involves the reconstruction of an existing outfall pipeline which under CEQA would be exempt. However, the project was treated in an EIR prepared for the overall project entitled, Combined Wastewater Control System, SCH #75081858.

- 2. A final Environmental Impact Report was prepared by the Sacramento Regional County Sanitation District, pursuant to CEQA and implementing regulations. A Notice of Determination has been received.
- This project is situated on State land identified as possessing significant environmental values pursuant to Public Resources Code 6370 L, and is classified in a use category, Glass R which authorizes Limited Use.

Staff has coordinated this project with those agencies and organizations who nominated the site as containing significant environmental values. They have found this project to be compatible with their nomination.

FURTHER APPROVALS REQUIRED:

Applicant indicates the following permits have been applied for, but have not been received: Water Quality Control Board. Fish and Game, Corps of Engineers, State Reclamation Board.

- 3. DETERMINE THAT THE PROJECT WILL NOT HAVE A SIGNIFICANT EFFECT ON THE ENVIRONMENT.
- 4. FIND THAT GRANTING OF THE PERMIT WILL HAVE NO SIGNIFICANT EFFECT UPON ENVIRONMENTAL CHARACTERISTICS IDENTIFIED PURSUANT TO SECTION 6370.1, OF THE PUBLIC RESOURCES
