TERMS OF PROPOSED LEASE:

15 years from December 1, Initial period:

1977.

Renewal options: 1 period of 10 years.

Surety bond:

\$5,000.

Public liability insurance: \$600,000 per occurrence for bodily

injury and \$100,000 for

property damage.

\$2,960 per annum, with the State reserving CONSIDERATION:

the right to fix a different rental on each fifth anniversary of the lease. The pier is no longer sublet, and produces

no direct income to the lessor.

BASIS FOR CONSIDERATION:

8% of appraised value of land.

PREREQUISITE TERMS, FEES AND EXPENSES:

Applicant is owner of upland.

STATUTORY AND OTHER REFERENCES:

Public Resources Code: Div. 6, Parts 1 & 2. Α.

B. Administrative Code: Title 2, Div. 3, Arts. 1, 2, 6.5,

10 & 11.

OTHER PERTINENT INFORMATION:

- An Environmental Impact Report is not required. This transaction is within the purview of 2 Cal. Adm. Code 2907, Class 1B, which exempts an existing structure or facility that is in an acceptable state of repair and there is no evidence of record to show injury to adjacent property, shoreline erosion, or other types of environmental degradation.
- 2. This project is situated on State land identified as possessing significant environmental values pursuant to Public Resources Code 6370.1, and is classified in a use category, Class A which authorizes Restricted Use.

CALENDAR ITEM NO. 19. (CONTD)

Staff review indicates that there will be no significant effect upon the identified environmental values. This is an existing facility for which no adverse comments have been received.

3. This structure has been in existence and under lease since November 22, 1954, and for this reason is exempt from Coastal Commission Guidelines.

 RENTAL ON EACH FIFTH ANNIVERSARY OF THE LEASE; PROVISION
 OF A \$5,000 SURETY BOND; PROVISION OF PUBLIC LIABILITY
 INSURANCE IN AMOUNTS OF \$600,000 PER OCCURRENCE FOR
