OTHER PERTINENT INFORMATION:

- 1. An Environmental Impact Report is not required. This transaction is within the purview of 2 Cal. Adm. Code 2907(a) which exempts an existing structure or facility that is in an acceptable state of repair and there is no evidence of record to show injury to adjacent property; shoreline erosion, or other types of environmental degradation.
- 2. This project is situated on State land identified as possessing significant environmental values pursuant to Public Resources Code 6370.1, and is classified in a use category, Class C which authorizes Multiple Use.

Staff review indicates that there will be no significant effect upon the identified environmental values. This is an existing facility for which no adverse comments have been received.

WP 643,

A strip of tide and submerged land 30 feet wide in the bed of the Napa River, County of Napa, State of California, said parcel being 15 feet on each side of the following described centerline:

BEGINNING at a point in the center of the levee along the easterly side of the Napa River from which U.S.C.&G.S. Triangulation Station "SUSCOL" bears N 49° 51' E 3827.6 feet; thence from said point of beginning, S 88° 41' W. 570 feet, more or less to the center of the levee along the westerly side of the Napa River and the end of herein described centerline.
