PROPOSED ANNEXATION

The City of Stockton, San Joaquin County, proposes to annex tide and submerged lands adjacent to its city limits. These tide and submerged lands are owned by the State of California and under the jurisdiction of the State Lands Commission. Section 35014, of the California Government Code, provides for the approval of disapproval by the State Lands Commission of the description of the offshore boundaries of an annexation that includes tide and submerged lands owned by the State; and for the neporting of its determination to the city and county and the Executive Officer of the Local Agency Formation Commission of the county. Staff review of the map and legal description of the proposed annexation shows compliance with the provisions of said section.

Approval of the map and of the legal description is made pursuant to Section 35014, of the California Government Cole, and does not constitute approval by the State, as owner of the tide and submerged lands of the proposed annexation. This matter will be the subject of separate, later consideration by the State Lands Commission.
