DREDGING PERMIT

APPLICANT:

City of Morro Bay  
695 Harbor Street  
Morro Bay, California 93442

PROPOSED DREDGING:

Maintenance dredging of approximately 70,000  
cubic yards of material from tide and submerged  
lands in the designated mooring area of  
Morro Bay Harbor; San Luis Obispo County.

OWNERSHIP:

The dredge area involves State tide and  
submerged lands, granted to the City of  
Morro Bay, with mineral reserves.

SPOILS PLACEMENT:

The proposed disposal site is an area im-  
mediately adjacent to a sand spit approximately  
3 miles south of the harbor entrance. The  
sand spit is State property under the jurisdic-  
tion of the Department of Parks and Recreation.  
Spoils will be transported via pipeline  
to the disposal site. The site has been  
approved by the Department of Parks and  
Recreation and all local agencies.

PURPOSE:

To maintain adequate water depths in the  
mooring areas for maneuvering and anchoring  
of boats.

CONSIDERATION: Public benefit, no royalty required.

ENVIRONMENTAL IMPACT CONSIDERATION:

This project is exempt from CEQA pursuant  
to Resources Agency Guidelines, Section  
15104 Class 4 (g) and 2 Cal. Adm. Code  
Section 2907 (a) Class 4 exempting maintenance  
dredging projects.

This project is situated on land identified  
as possessing significant environmental  
values pursuant to Public Resources Code  
6370.1 and is classified in a Class A use  
category, which authorizes restricted uses.

Staff review indicates that there will be no significant effect upon identified environmental values.

TERM: The permit to be effective from March 30, 1978 through December 31, 1978.

OTHER PERTINENT DATA:

The type of material to be removed is sand and silt. The material is being removed by the United States Army Corps of Engineers from State granted lands and deposited on State-owned lands. According to the proposed plan, spoils will not be sold or used for any other purpose.

IT IS RECOMMENDED THAT THE COMMISSION:

1. DETERMINE THAT AN EIR HAS NOT BEEN PREPARED FOR THIS ACTIVITY AS SUCH REPORT IS NOT REQUIRED UNDER THE PROVISIONS OF PRC 21085, 14 CAL. ADM. CODE 15104 (g), AND 2 CAL. ADM. CODE 2907.
2. FIND THAT GRANTING OF THE PERMIT WILL HAVE NO SIGNIFICANT EFFECT UPON ENVIRONMENTAL CHARACTERISTICS IDENTIFIED PURSUANT TO SECTION 6370.1, OF THE PUBLIC RESOURCES CODE.
3. AUTHORIZE THE ISSUANCE OF A DREDGING PERMIT TO THE CITY OF MORRO BAY TO DREDGE APPROXIMATELY 70,000 CUBIC YARDS OF MATERIAL FROM AN AREA OF GRANTED TIDE AND SUBMERGED LANDS IN MORRO BAY HARBOR, SAN LUIS OBISPO COUNTY, SUCH AREA BEING DESCRIBED IN EXHIBIT "A" ATTACHED AND BY REFERENCE MADE A PART HEREOF; AT NO ROYALTY, THE CONSIDERATION BEING THE PUBLIC BENEFIT, AND TO

SPOIL SUCH MATERIAL ON STATE-OWNED LANDS; PERMIT TO  
BE EFFECTIVE MARCH 30, 1978 THROUGH DECEMBER 31, 1978;  
SUCH PERMISSION BEING SUBJECT TO ISSUANCE OF ALL OTHER  
REQUIREMENTS, RECOMMENDATIONS, OR LIMITATIONS AS SET  
OR AS MAY BE SET BY STATE, FEDERAL, OR LOCAL GOVERNMENT.
