AREA, TYPE LAND AND LOCATION:

A 1,925 square foot, approximately 0. 04 acre parcel of tide and submerged land lying in the bed of Tomales Bay, Marin

County.

LAND USE:

Public pier and boat dock.

TERMS OF PROPOSED PERMIT:

Initial period: 10 years from April 1, 1978.

Public liability insurance: Combined single limit coverage of \$100,000.

CONSIDERATION: \$40 per annum.

BASIS FOR COMSIDERATION:

\$40 fixed rental for this type of permit.

PREREQUISITE TERMS, FEES AND EXPENSES:

Applicant is owner of upland. Upland is unimproved. Applicant has allowed use of the area for loading and unloading by commercial and recreational fishermen.

Filing fee has been received.

STATUTORY AND OTHER REFERENCES:

A. Public Resources Code: Div. 6, Parts 1 & 2.

B. Administrative Code: Title 2, Div. 3, Arts. 1, 2, 6.5, 10 & !1.

OTHER PERTINENT INFORMATION:

A Negative Declaration was prepared by Marin County, pursuant to CEQA and implementing regulations. A Notice

of Determination has been received.

This project is situated on State land identified as possessing significant environmental values pursuant to Public Resources Code 6370.1, and is classified in a use category. Class B which authorizes limited use.

Staff has coordinated this project with those agencies and organizations who nominated the site as containing significant environmental values. They have found this project to be compatible with their nomination.

- Coastal Zone approval for this pier is contingent upon it's being open for public use. Public recreational facilities are encouraged and generally can conform to coastal guidelines under Article 3, Sections 30220-30224 of the Coastal Act. The applicant has agreed to this provision.
- The Commission at its meeting on February 23, 1978, authorized a "Letter of Understanding" between the State Lands Commission, North Central Regional Coastal Commission and County of Marin. This understanding was implemented to express the working relationship among the parties during the formulation of Marin County's Local Coastal Frogram in the Tomales Bay Area. All parties to this "Letter of Understanding" have reviewed this project and have made no adverse comments. This project contemplates a continuation of a use which is consistent with the public trust.

Coastal Zone Permit.
