PROTECTIVE STRUCTURE

APPLICANT: Hilary E. Abramson

AREA, TYPE LAND AND LOCATION:
A 0.127 acre parcel of tide and submerged
land in the bed of the Sacramento River,
north of the Interstate Highway 5 crossing
in Sacramento County

LAND USE: Construction and maintenance of rock riprap
bank protection.

TERMS OF PROPOSED PERMIT:
Initial period: 25 years from April 1,
1978.

CONSIDERATION: No monetary consideration required, public
benefit will accrue, with the State reserving
the right at any time to set a monetary
rental if the Commission finds such action
to be in the State's best interest.

PREREQUISITE TERMS, FEES AND EXPENSES:
Applicant is owner of upland.
Filing fee has been received.

STATUTORY AND OTHER REFERENCES:
A. Public Resources Code: Div. 6, Parts 1 & 2.
B. Administrative Code: Title 2, Div. 3,
Arts. 1, 2, 10 & 11.

OTHER PERTINENT INFORMATION:
1. The annual rental value of the site
is estimated to be \$150.
2. Staff feels that the construction of

be of mutual benefit to both the public and the applicant. The public levee will have additional protection from wave action at no cost to the public, also less eroded material will be deposited in ship channels which are maintained at public expense. The applicant will benefit from the protection of the existing home site.

3. Staff has recommended waiving the normal processing costs in this case because the transaction required minimum staff time and the protective structure was for an individual home site.
4. This project is exempt from CEQA because it is a minor alteration to the land and will not require the removal of any mature or scenic trees.

Authority: 14 Cal. Adm. Code 15104
Class 4 Minor Alterations to Land.

5. This project is situated on State land identified as possessing significant environmental values pursuant to Public Resources Code 6370.1, and is classified in a use category, Class B which authorizes Limited Use.

Staff has coordinated this project with those agencies and organizations who nominated the site as containing significant environmental values. They have found this project to be compatible with their nomination.

A parcel of tide and submerged land in the Sacramento River, Sacramento County, California, within Section 23, T.10N., R.3E., M.D.M., described as follows:

All that land immediately beneath the rip rap bank protection adjacent to that certain Lot 139 as shown on the "Map of Natomás Elkhorn Subdivision", filed in the office of the County Recorder of Sacramento County on February 26, 1918, in Book 15 of Maps, Map No. 42.

EXCEPTING THEREFROM any portion lying landward of the ordinary high water mark of the left bank of the Sacramento River.
