GENERAL PERMIT PUBLIC AGENCY USE

APPLICANT:

California Department of Fish and Game 1416 Ninth Street Sacramento, California 95814

AREA, TYPE LAND AND LOCATION:

Tide and submerged land in the Pacific Ocean contiguous to Anacapa and Santa Barbara Islands. The areas within the proposed reserves will be situated between the mean high tide line and 1 mile waterward around each island.

LAND USE: Establishment and operation of ecological reserves.

TERMS OF PROPOSED PERMIT: Initial period:

49 years from September 1, 1978.

Special:

The Commission is reserving the right to drill and produce oil and gas should the demised area become subject to drainage from adjacent wells.

CONSIDERATION: The public use and benefit with the State reserving the right at any time to set a monetary rental if the Commission finds such action to be in the State's best interest.
