APPLICANT:

County of San Joaquin 1810 East Hazelton Avenue Stockton, California 95201

AP' , TYPE LAND AND LOCATION:

A .172 acre parcel of filled tide and submerged land in the old bed of Black Slough, San

Joaquin County.

LAND USE:

The reconstruction and maintenance of a public roadway on an existing levee along the Stockton Deep Water Channel.

TERMS OF PROPOSED PERMIT:

Initial period:

49-years from January 1, 1978.

CONSIDERATION:

The public use and benefit, with the State reserving the right at any time to set a monetary rental if the Commission finds such action to be in the State's best interest.

PREREQUISITE TERMS, AND EXPENSES: Applicant is owner of upland.

STATUTORY AND OTHER REFERENCES:

Public Resources Code: Div. 6, Parts 1 & 2.

Adm. Code: Title 2, Div. 3.

OTHER PERTINENT INFORMATION:

The county's project involves the reconstruction and continued maintenance as a part of the county road system, of an existing roadway which has been privately maintained for a long period of time, on an existing levee constructed as part of the Stockton Deep Water Channel.

- An EIR is not required. This transaction is within the purview of 2 Cal. Adm. Cade 2907, Class 1k, which exempts an existing structure or facility that is in an acceptable state of repair and there is no evidence of record and there is no evidence of teopy, to show injury to adjacent property, shoveline erosion, or other types of environmental degradation, and 14 Cal. Adm. Gode 15102 - Reconstruction or replacement of existing facilities.
  - This project is situated on State land Identified as possessing significant environmental values pursuant to Public Resources Code 6370.1, and is classified in a use category, Class B, which authorizes Limited Use.

Staff review indicates that there will be no significant effect upon the identified environmental values. This is an existing facility for which no adverse comments have been received.

Staff recommends that the required processing fee be waived in this case. The proposed project is being constructed using county maintenance forces and no funds were budgeted to provide for payment of additional costs other than normal road maintenance costs. County has requested that because of the high cost of preparing augments to their budget that the processing fee be waived in this case.

## LAND DESCRIPTION

A strip of tide and submerged land 50 feet in width crossing Black Slough, San Josquin County, California, said scrip lying 25 feet on each side of the following described centerline:

BEGINNING at a fron pin stamped "RCE 9338", in the southerly levee of the Stockton Deep Water Channel, that bears N 84" 21' 12" E, 395.65 feat from a U.S.C.E. Bench Mark having Callfornia Coordinate System Zone II coordinates of X = 2,166,872.93 feet Y = 119,873.46 feet, thence from said point of beginning S 75° 08' 24" E, 251.55 feet; thence N 83° 41' 27" E, 494.90 feet, thence S 80° 54' 44" E, 86.83 feet to the thence S 89° 07' 14" E, 86.60 feet; thence S 80° 54' 44" E, 86.83 feet to the end of the herein described centerline.

Rearings and distances used in the above description are based on the California Coordinate System, Zone II.
