CUTTING BOUNDARY AGREEMENT BETWEEN
STATE LANDS COMMISSION AND SOUTHERN PACIFIC LAND COMPANY

In August 1977, the Southern Pacific Land Company contacted the Commission's staff regarding their plan for conducting a 1979 timber sale on company-owned lands in the NE $\frac{1}{4}$ of Section 17, T35N, R5W, MDM, Shasta County. It had been confirmed by the company that the adjoining Section 16 was State school land and logging on their timber sale area will take place along approximately 1,000 feet of the common boundary (section line) between the State and Southern Pacific lands.

Company personnel undertook a diligent search for the official Public Land Survey corners common to the aforesaid sections. No official monumented section corners could be found along the boundary. Due to the absence of such section corners, Southern Pacific Land Company requested the State's agreement as to a common boundary location.

The Commission's staff has negotiated a cutting boundary agreement with the company, following the establishment of a reasonable boundary line on the ground to the mutual satisfaction of both parties. The content of the agreement is similar to other such agreements previously approved by the Commission.

This cutting boundary agreement will facilitate both the State and Southern Pacific Land Company in the harvesting of merchantable timber from their respective lands without a costly resurvey in remote and mountainous country.

OTHER PERTINENT INFORMATION:

This project is situated adjacent to State land identified as possessing significant environmental values pursuant to P.R.C. 6370.1, and is classified in a use category, Class A, which authorizes Restricted Use.

Staff review indicated that there will be no significant effect upon environmental characteristics of the State lands identified pursuant to Section 6370.1 of the P.R.C.


