DREDGING PERMIT EXTENSIONS

In accordance with the Commission's delegation of authority to the Executive Officer for the issuance of dredging permits for 10,000 cubic yards or less, permission has been granted to extend 2 maintenance dredging permits on State-owned submerged lands in Lake Tahoe to the following parties:

Dredging Permit PRC 5397.1 was issued to remove approximately 2,400 cubic yards of material, effective from October 3, 1977, through December 31, 1978. An extension has been granted from January 1, 1979, through August 31, 1979. Spoils will be placed on private property at a royalty of \$0.25 per cubic yard.

Dredging Permit PRC 5418.1 was issued to remove approximately 8,000 cubic yards of material, effective from December 15, 1977, through December 31, 1978. An extension has been granted from January 1, 1979, through August 31, 1979. Spoils will be placed on private property at a royalty of \$0.25 per cubic yard.

CALENDAR ITEM NO. C12. (CONTD)

1. The proposed project is categorically exempt from the requirements of CEQA.
2. The issuance of the permit extension and the resultant project will have no significant adverse effect upon the environment or the environmental characteristics identified pursuant to Section 6370.1 et seq. of the P.R.C.
3. The dredging amount will not exceed 10,000 cubic yards.
4. A charge per cubic yard shall be assessed for spoil material that is removed from State-owned lands and deposited on private property, used commercially, or otherwise lost to future State benefit.
5. State Lands Commission approval of the project and issuance of the permit extension will be contingent upon approval by all pertinent State, federal and local agencies.

A parcel of land in the bed of Lake Tahoe, El Dorado County, California, situated adjacent to fractional Section 27, T13N, R18E, M.D.M., more particularly described as follows:

BEGINNING at the most southerly corner of Lot 3, as shown on the map of Lakeside Lodge Subdivision, filed in map book "A", at page 31, El Dorado County records; thence along the southeasterly line and its northeasterly extension of lots 3, 2 and 1 of said Lakeside Lodge Subdivision, N 25° 46' 40" E, 261 feet; thence N 64° 13' 20" W, 362 feet; thence N 25° 46' 40" E, 31 feet; thence N 64° 13' 20" W, 21 feet; thence S 25° 46' 40" W, 130 feet; thence S 64° 13' 20" E, 37 feet; thence S 25° 46' 40" W, 144.02 feet; thence S 64° 13' 20" E, 192.53 feet to the most westerly corner of said Lot 3; thence along the southwesterly line of said Lot 3, S 57° 32' 30" E, 154.52 feet to the point of beginning.

EXCEPTING THEREFROM any portion lying landward of the ordinary high-water mark of Lake Tahoe.




