GENERAL PERMIT  
PROTECTIVE STRUCTURE

APPLICANT: Southern California Edison Company  
P. O. Box 410  
Long Beach, California 90801

Attn: Joseph O. Davidson

AREA, TYPE LAND AND LOCATION:  
A 0.38 acre parcel of tide and submerged  
land in the Pacific Ocean at El Segundo,  
Los Angeles County.

LAND USE: Beach erosion control by the installation  
of a rock barrier.

TERMS OF PROPOSED LEASE:

Initial period: 20 years from February 1,  
1979.

Surety bond: \$10,000.

Insurance: The lessee shall maintain  
comprehensive general  
liability insurance coverage,  
consisting of a self-insured  
status for the first  
\$1,000,000, and excess  
liability insurance program  
with a combined single  
limit of \$100,000,000  
covering the leased premises.

CONSIDERATION: No monetary consideration required, public  
benefit will accrue, with the State reserving  
the right at any time to set a monetary  
rental if the Commission finds such action  
to be in the State's best interest.

PREREQUISITE TERMS, FEES AND EXPENSES:

Applicant is owner of upland.

Filing fee and processing costs have been  
received.

OTHER PERTINENT INFORMATION:

1. The annual rental value of the site is estimated to be \$10,000.
2. The proposed protective structure replaces a temporary rock barrier that was placed during an emergency condition that occurred as a result of storm damage in the winter of 1978. The proposed structure protects a public bicycle trail on State-owned property as well as Southern California Edison's plant.
3. This project is exempt from CEQA because of 2 Cal. Adm. Code, Class 2, Section 15102, replacement or reconstruction of a facility. The staff contacted responsible and other agencies relative to this project and to date has received no negative comments on this project.
4. This project is situated on State land identified as possessing significant environmental values pursuant to P.R.C. 6370.1, and is classified in a use category, Class C, which authorizes Multiple Use.

Staff has coordinated this project with those agencies and organizations who nominated the site as containing significant environmental values. They have found this project to be compatible with their nomination.

5. This project is consistent with Art. 6.5 of 2 Cal. Adm. Code and the applicant will be obtaining a Coastal Zone Permit, as provided for under Sections 2579 and 30235 of the P.R.C.

IT IS RECOMMENDED THAT THE COMMISSION:

1. DETERMINE THAT AN EIR HAS NOT BEEN PREPARED FOR THIS ACTIVITY AS SUCH REPORT IS NOT REQUIRED UNDER THE PROVISIONS OF P.R.C. 21085, 14 CAL. ADM. CODE 15100 ET SEQ., AND 2 CAL. ADM. CODE 2907.
2. DETERMINE THAT THE PROJECT IS CONSISTENT WITH THE PROVISIONS OF ARTICLE 6.5, OF TITLE 2, OF THE CAL. ADM. CODE.
3. FIND THAT GRANTING OF THE PERMIT WILL HAVE NO SIGNIFICANT EFFECT UPON ENVIRONMENTAL CHARACTERISTICS IDENTIFIED PURSUANT TO SECTION 6370.1, OF THE P.R.C.
4. AUTHORIZE ISSUANCE TO SOUTHERN CALIFORNIA EDISON COMPANY OF A 20-YEAR GENERAL PERMIT - PROTECTIVE STRUCTURE FROM FEBRUARY 1, 1979; IN CONSIDERATION OF THE PUBLIC BENEFIT WITH THE STATE RESERVING THE RIGHT AT ANY TIME TO SET A MONETARY RENTAL IF THE COMMISSION FINDS SUCH ACTION TO BE IN THE STATE'S BEST INTEREST; PROVISION OF A \$10,000 SURETY BOND; PROVISION THAT THE LESSEE SHALL MAINTAIN A COMPREHENSIVE GENERAL LIABILITY INSURANCE COVERAGE, CONSISTING OF A SELF-INSURED STATUS PROGRAM, WITH A COMBINED SINGLE LIMIT OF \$100,000,000 COVERING THE LEASED PREMISES FOR THE PLACEMENT AND MAINTENANCE OF A ROCK BARRIER ON THE LAND AS SHOWN ON EXHIBIT "A" ATTACHED AND BY REFERENCE MADE A PART HEREOF.



