PROPOSED ANNEXATION

The City of Stockton, San Joaquin County, proposes to annex an area which includes tide and submerged lands adjacent to it. Its tide and submerged lands are owned by the State of California and under the jurisdiction and trusteeship of the State Lands Commission. California Government Code Section 35009 provides for the approval or disapproval by the State Lands Commission of the description of tide and submerged land boundaries submitted for a proposed annexation. The code section further provides for the reporting of such determination to the Executive Officer of the Local Agency Formation Commission (LAFCO) and the city, county, local agency, person or persons, if any, who filed the boundary description and map.

Staff review of the map and the legal description is made pursuant to Government Code Section 35009 and does not constitute approval by the State (as owner of tide and submerged lands) of the proposed annexation. This matter will be the subject of separate, later consideration by the State Lands Commission.

IT IS RECOMMENDED THAT THE COMMISSION APPROVE THE PROPOSED BOUNDARIES OF THE PROPOSED ANNEXATION BY THE CITY OF STOCKTON AS DESCRIBED IN EXHIBIT "A" ATTACHED AND BY REFERENCE MADE A PART HEREOF, AS REQUIRED BY CALIFORNIA GOVERNMENT CODE SECTION 35009, AND AUTHORIZE STAFF COUNSEL TO GIVE THE REQUISITE NOTICES OF SAID APPROVAL TO THE COUNTY OF SAN JOAQUIN, CITY OF STOCKTON, AND THE EXECUTIVE OFFICER OF THE LOCAL AGENCY FORMATION COMMISSION OF SAN JOAQUIN COUNTY.

EXHIBIT "A"

LAND DESCRIPTION

W 2400.122

All that certain piece or parcel of land situate, lying and being in portions of Sections 5,6 and 7 of Township 1 North, Range 6 East, Mount Diablo Base and Meridian, County of San Joaquin, State of California, and being more particularly described as follows, to wit:

Beginning at the intersection of the center line of the Stockton Deep Water Channel with the southerly projection of the center line of the old channel of the San Joaquin River (said channel now known as Atherton Cove), said intersection being on the existing City limits line of the City of Stockton; thence leaving said City limits line northeasterly, along said southerly projection, 800 feet, more or less, to the center of that certain body of water lying south of Atherton Island, known as Lindley Cut; thence southeasterly, meandering the center of said Lindley Cut, 1500 feet, more or less, to a point on the southwesterly projection of the center line of Smith's Canal, said point being on said existing City limits line; thence southwesterly, along said southwesterly projection and said existing City limits line, 650 feet, more or less, to the aforesaid center line of the Stockton Deep Water Channel; thence northwesterly, along said center line and said existing City limits line, 1750 feet, more or less, to the hereinbefore mentioned POINT OF BEGINNING.


