GRAZING LEASE

APPLICANT:

AREA, TYPE LAND AND LOCATION:

199 ± acres, consisting of 4 parcels of
vacant school land located on the west
side of Owens Lake in Inyo County, California;
said parcels being the fractional E½ of
Section 7 and the fractional E½ of Section 18,
T18S, R37E, MDM, and the fractional N½
of the N½ of Section 30 and the fractional
NE½ of the SW½ of Section 30, T17S, R37E,
MDM, as shown on the official township
plat containing said parcels.

LAND USE:

Grazing

TERMS OF PROPOSED LEASE:

Initial period: 10 years from December 14,
1975.

Public liability insurance: Combined single
limit coverage of \$100,000.

CONSIDERATION:

\$199 per annum, with the State reserving
the right to fix a different rental on
each fifth anniversary of the lease.

BASIS FOR CONSIDERATION:

The rental is based on the applicant's
offer of \$1 per acre per year. This rate
is in excess of the market value determined
by staff appraisal which considered a charge
by animal unit months.

PREREQUISITE TERMS, FEES AND EXPENSES:

Filing fee and annual rentals for period
of December 14, 1975 through December 13,
1979 in the amount of \$796 have been received.

STATUTORY AND OTHER REFERENCES:

OTHER PERTINENT INFORMATION:

1. The applicant has not been advised of the recent requirement of liability insurance as of this date. Documents will not be executed until this requirement has been met.
2. This project is exempt from CEQA under 2 Cal. Adm. Code Article 10, Section 2907, Class 4(A), "Grazing of livestock where disturbance of soil does not occur."
3. This project is situated in part on State land identified as possessing significant environmental values pursuant to P.R.C. 6370.1; the fractional E $\frac{1}{2}$ of Section 7, T18S, R37E, MDM, only is classified in a use category, Class B, which authorizes Limited Use.
4. Staff has coordinated this project with those agencies and organizations who nominated the site as containing significant environmental values. They have found this project to be compatible with their nomination.
5. The subject vacant school lands have been leased to Mr. Roy Hunter, under prior grazing leases authorized by the Commission.

2. FIND THAT GRANTING OF THE LEASE WILL HAVE NO SIGNIFICANT EFFECT UPON ENVIRONMENTAL CHARACTERISTICS IDENTIFIED PURSUANT TO SECTION 6370.1, OF THE P.R.C.
3. AUTHORIZE ISSUANCE TO ROY HUNTER OF A 10-YEAR GRAZING LEASE FROM DECEMBER 14, 1975, IN CONSIDERATION OF ANNUAL RENT IN THE AMOUNT OF \$199, WITH THE STATE RESERVING THE RIGHT TO FIX A DIFFERENT RENTAL ON EACH FIFTH ANNIVERSARY OF THE LEASE; PROVISION OF PUBLIC LIABILITY INSURANCE IN THE AMOUNT OF \$100,000 SINGLE LIMIT COVERAGE FOR BODILY INJURY AND PROPERTY DAMAGE, FOR GRAZING OF LIVESTOCK ON THE LAND DESCRIBED ON EXHIBIT "A" ATTACHED AND BY REFERENCE MADE A PART HEREOF.


