GENERAL PERMIT
RECREATIONAL USE

APPLICANT: Angelo J. Grossi and
Rita V. Logan
5636 Lakeville Highway
Petaluma, California 94952

TYPE LAND AND LOCATION:
Tide and submerged land in the Petaluma
River, near Lakeville, Sonoma County.

LAND USE: Walkway, boat dock and other appurtenant
recreational facilities.

TERMS OF PROPOSED PERMIT:
Initial period: 10 years from July 1,
1979.

Public liability insurance: Combined single
limit coverage of \$100,000.

CONSIDERATION: \$30 per annum, with the State reserving
the right to fix a different rental on
each fifth anniversary of the permit.

BASIS FOR CONSIDERATION:
\$30 minimum rental for this type of permit.

FEES AND EXPENSES:
Filing fee and first year's rental have
been received.

STATUTORY AND OTHER REFERENCES:
A. P.R.C.: Div. 6, Parts 1 & 2.
B. Cal. Adm. Code: Title 2, Div. 3.

OTHER PERTINENT INFORMATION:
1. Permittee is in physical possession
of an existing single family residence
and appurtenant structures encroaching
on the tide and submerged lands described
in Exhibit "A". Ownership of the littoral
land is currently in dispute between
the proposed permittee and the owner
of record.

2. An EIR is not required. This transaction is within the purview of 2 Cal. Adm. Code 2907, Class 1(B), which exempts an existing structure or facility that is in an acceptable state of repair and there is no evidence of record to show injury to adjacent property, shoreline erosion, or other types of environmental degradation.
3. This project is situated on State land identified as possessing significant environmental values pursuant to P.R.C. 6370.1, and is classified in a use category, Class B, which authorizes Limited Use.

Staff review indicates that there will be no significant effect upon the identified environmental values. This is an existing facility for which no adverse comments have been received.

IT IS RECOMMENDED THAT THE COMMISSION:

1. DETERMINE THAT AN EIR HAS NOT BEEN PREPARED FOR THIS ACTIVITY AS SUCH REPORT IS NOT REQUIRED UNDER THE PROVISIONS OF P.R.C. 21085, 14 CAL. ADM. CODE 15100 ET SEQ., AND 2 CAL. ADM. CODE 2907.
2. FIND THAT GRANTING OF THE PERMIT WILL HAVE NO SIGNIFICANT EFFECT UPON ENVIRONMENTAL CHARACTERISTICS IDENTIFIED PURSUANT TO SECTION 6370.1, OF THE P.R.C.
3. AUTHORIZE ISSUANCE TO ANGELO J. GROSSI AND RITA V. LOGAN OF A 10-YEAR GENERAL PERMIT - RECREATIONAL USE FROM JULY 1, 1979; IN CONSIDERATION OF ANNUAL RENTAL IN THE AMOUNT OF \$30, WITH THE STATE RESERVING THE RIGHT TO FIX A DIFFERENT RENTAL ON EACH FIFTH ANNIVERSARY OF THE PERMIT; PROVISION OF PUBLIC LIABILITY INSURANCE, COMBINED SINGLE LIMIT COVERAGE OF \$100,000; FOR EXISTING WALKWAY, BOAT DOCK AND OTHER APPURTENANT RECREATIONAL FACILITIES ON THE LAND DESCRIBED ON EXHIBIT "A" ATTACHED AND BY REFERENCE MADE A PART HEREOF.


