MINUTES OF THE STATE LANDS COMMISSION
MEETING OF
NOVEMBER 20, 1979

The regular meeting of the State Lands Commission was called to order by Chairman Kenneth Cory at 10:05 a.m. in Room 6028, State Capitol. Also present were Commission Alternates Roy Bell, representing Commissioner Mary Ann Graves, Director of Finance; and David Ackerman, representing Commissioner Mike Curb, Lieutenant Governor.

The minutes of the meeting of October 29, 1979, were approved as presented.

EXECUTIVE OFFICER'S REPORT:

With regard to funding of EIR's, outlined in the attached Executive Officer's report, Commission-alternate Roy M. Bell suggested that the staff augment its budget through a special bill instead of requesting the funds from the Department of Finance as the latter option would not be realized until June of 1980.

In addition, the Commission consented to the staff directly responding to local coastal plans unless the comments are counter to Commission policy.

FUNDING OF EIR'S

THE COMMISSION HAS THE OPPORTUNITY TO TAKE SOME STEPS OF IMMEDIATE HELP TO THE STATE'S ENERGY NEEDS. AN ADDITIONAL OIL AND GAS FIELD CAN BE EXPLORED AND RAPIDLY DEVELOPED WITH EXISTING CONVENTIONAL TECHNOLOGY. FURTHER GEOTHERMAL RESOURCES CAN ALSO BE DEVELOPED IN THE GEYSERS AREA. WHAT IS NEEDED FIRST, IN EACH CASE, IS THE INITIAL FUNDING FOR DATA COLLECTION AND ENVIRONMENTAL CONSIDERATIONS.

OFFSHORE LANDS NEAR PT. CONCEPTION, SANTA BARBARA COUNTY, CAN BE CONSIDERED AN EXCELLENT PROSPECT FOR OIL AND GAS LEASING. THIS AREA IS BORDERED BY HIGH BONUS-BID FEDERAL LEASES. BEFORE A DECISION CAN BE MADE ON WHETHER OR NOT TO LEASE THESE LANDS, THE ENVIRONMENTAL IMPACTS OF THIS ACTION MUST BE EVALUATED. ADDITIONALLY, A RESOURCE VALUATION MUST BE MADE IN ORDER TO DETERMINE THE BEST PROCEDURES FOR LEASING THE LANDS. APPROXIMATELY \$500,000 WILL BE NEEDED FOR THIS WORK.

AT THE GEYSERS, \$100,000 IS REQUIRED FOR PREPARATION BY CONTRACT OF ENVIRONMENTAL IMPACT REPORTS. THESE WOULD BE THE PRELUDE TO COMPETITIVE LEASING OF STATE-OWNED GEOTHERMAL LANDS.

THERE IS CURRENTLY NO PROVISION FOR ADVANCE FUNDING FOR GEOLOGIC AND GEOPHYSICAL EXPLORATION OR EIR PREPARATION FOR THE COMMISSION'S COMPETITIVE ENERGY RESOURCE LEASE PROGRAM.

THESE ACTIVITIES COULD BEGIN AT ONCE IF THE FUNDS WERE AVAILABLE NOW. WITH YOUR CONSENT, I PROPOSE TO LOOK FOR THESE FUNDS THROUGH VARIOUS ALTERNATIVES, INCLUDING POSSIBLE BUDGET AUGMENTATION OR LEGISLATION.
