AREA, TYPE LAND AND LOCATION:

A 0.069 acre parcel and a 0.029 acre circular
parcel, 40 feet in diameter, all on submerged
lands in McKinney Bay, Lake Tahoe near
Tahoma, Placer County.

LAND USE:

Maintenance of 1 existing pier and 1 existing
mooring buoy, respectively, for recreational
boating.

TERMS OF ORIGINAL PERMIT:

Initial period: 15 years from December 1,
1978.

Public liability insurance: \$400,000 per
occurrence for bodily
injury and \$50,000 for
property damage, or combined
single limit coverage
of \$450,000.

CONSIDERATION:

\$70 per annum, with the State reserving
the right to fix a different rental on
each fifth anniversary of the permit.

PREREQUISITE TERMS, FEES AND EXPENSES:

Applicant is owner of upland.

Filing fee and processing costs have been received.

STATUTORY AND OTHER REFERENCES:

A. P.R.C.: Div. 6, Parts 1 & 2.

B. Cal. Adm. Code: Title 2, Div. 3.

OTHER PERTINENT INFORMATION:

1. This transaction is occasioned by the sale of the upland to the proposed assignees. Assignors have filed with staff an express statement objecting to the words and phrases in the Commission's assignment document which bind the assignors, for the remaining term of the permit, to the faithful performance of any and all future obligations in the same degree as the effective permittee. Assignors desire to be released from this liability.

By the act of entering into said assignment, assignees bind themselves to the obligations of the original permittees. Staff considers assignees to be capable of fulfilling the obligations of the permit, and recommends that assignors be released from said liability.

2. This activity is exempt from CEQA because it does not constitute a project.
3. The existing facilities are situated on State land identified as possessing significant environmental values pursuant to P.R.C. 6370.1, and is classified in a use category, Class B, which authorizes Limited Use.

Staff review indicates that there will be no significant effect upon the identified environmental values. These are existing facilities for which no adverse comments have been received.


